Minutes of Second Managing Committee meeting held on 24th January 2018 At PAAPAM Head Office Lahore and Zonal Office Karachi via video link.

The Second Managing Committee meeting was held on 24th January 2018 at PAAPAM Head Office Lahore and Zonal Office Karachi via video link. The Meeting was presided over by Chairman Mr. Iftikhar Ahmad and Senior Vice Chairman Mr. Muhammad Ashraf Shaikh. The list of participants at respective locations is attached.

The proceedings of the meeting commenced with recitation from The Holy Quran by Mr. Anas Haroon.

Mr. Iftikhar Ahmad welcomed the participants and praised them for taking active participation in the affairs of association.

Thereafter the agenda items were taken up as under:

Item # 1: Briefing on visit of Mr. Saquib H. Shirazi Chairman PAMA to PAAPAM Head Office.

Chairman informed the house that Mr. Saquib H. Shirazi visited PAAPAM Head Office recently. This was the first visit of any OEM to PAAPAM Head Office. Mr. Saquib H. Shirazi praised the PAAPAM Management for their consecutive achievements for betterment of its members and developing cordial relations with OEMs.

Mr. Saquib H. Shirazi proposed that both organizations should join hands for training and development of work force in the automotive industry through PAAPAM Development Center (PSDC) and Atlas Honda School.

In order to materialize the concept of reciprocal exchange of Trainers, Chairman PAAPAM will soon visit Atlas Honda School.

Item # 2: De-briefing on preparations for Pakistan Auto Show 2018.

Chairman PAAPAM informed the house that 90% stalls and open space has been booked by PAAPAM members and other exhibitors. He requested Sr. Vice Chairman for pursuing M/S TMD International for participation in Pakistan Auto Show 2018 and finalize the price.

Item # 3: To Initiate proposals for upcoming Federal Budget.

Mr. Muhammad Ashraf Sheikh Sr. Vice Chairman told the house that Mr. Munir K. Bana is working on proposals for upcoming Federal Budget and Strategic Trade Policy 2018-23. As soon as proposals are finalized the same will be shared with North Members.

Item # 4: De-briefing on PSDC Activities.

Chairman informed the house that PSDC's activities are at its peak, so far 85 Seminars / Workshops has been organized on both locations on different Industry related topics. A space of 2000 Sq. ft. has been reserved for Seminars during Pakistan Auto Show 2018. A handsome amount has also been allocated for grant of Innovation Awards during PAPS 2018.

Item # 5: Approval of New Membership.

Sr. Vice Chairman informed that M/S M.A.K. Automotive Private Limited has applied for PAAPAM Membership. He proposed that approval may be granted subject to verification of their unit. The house granted approval subject to aforesaid condition, unanimously.

Others:

- A. Chairman pointed out that activities carried out at North do not find appropriate coverage in bi-monthly newsletter. Sr. Vice Chairman assured that he will look into the matter and it will be resolved in future issues of newsletters.
- B. Mr. Iftikhar Ahmad proposed to hold 1st International Conference on Best Practices in Global Automotive Industry / Automotive Show at Islamabad. The house granted approval unanimously.
