

3	To update on the commercialization of the head office	Mr. Taufiq Ahmed Sherwani briefed the House regarding the progress of the PAAPAM Head Office commercialization. 5	To update the AAPEX Show 2024	Mr. Ghulam Murtaza updated the committee members on the participation of interested companies at AAPEX Las Vegas 2024. Seven Companies had shown their expression of interest with respect to their valid US Visas and commitment of Rs 01 million to PAAPAM Head office, which includes AMMARIAN Industries, Kor Tech Industries Pvt Ltd, Metalline Industries Pvt Ltd, ATLAS Autos, A-one Techniques, National Automotive components, Mekas Engineering Pvt Ltd have shown their confirmation		
6	To discuss the updates of PAPS 2024	Mr. Rehan Riaz briefed the members on the working of Pakistan Auto Show 2024. He added that the hall layout, pricing inclusive of sale tax, Website, and the launching ceremony of Pakistan Auto Show have been finalized, and you are all invited to the launching ceremony of PAPS 2024 on 7th March, Grand Ballroom C Nishat Hotel Johar Town Emporium Mall. Chairman Mr. Abdur Rehman Aizaz Acknowledge the efforts of PAPS Organizing committee and Mr. Rehan Riaz Convener PAPS OC 2024; further, he added that support from the PAAPAM South office is always available with you and two of the MC Members shall attend PAPS Launching

7	To discuss the issues hurting the industry for taking up the new government / SIFC	Mr. Abdur Rehman Aizaz, the Chairman, briefed the committee members on the challenges the local assemblers and the auto parts manufacturers faced. He added that the duties on the imports of used cars had been removed, while the additional duty of 100% + ACD of 15% has been imposed on the new cars being manufactured in Pakistan, So the cars in the current scenario above 1000 CC remained expensive versus the import of used cars. Therefore, PAAPAM needs to prepare a detailed response to the above matter.		
8	To discuss the request letter of the Special Investment Facilitation Council	The Chairman briefed the PAAPAM was writing a letter to SIFC and relevant ministries about the issues discussed above.		
9	To discuss the Amnesty case of Islam Engineering Pvt Ltd	Mr. Muhammad Naseem put forward the case of Islam Engineering for approval, but this decision was deferred because members highlighted that in the past, Islam Engineering was accused of misusing Raw Material imported under IORC; therefore, it was decided by the members to take an update on the above-mentioned issue also take an assurance from Islam Engineering that they would not be involved in any other unlawful activity in future.
