2. Agenda. To review the decision taken during the 27th Annual General Meeting (AGM) held on 3 December 2025 regarding the increase in Annual Membership Fees:

- a. **Annual Membership Fee approved in 27th AGM:**
 - 1) Associate Members: Rs. 30,000
 - 2) Corporate Members: Rs. 60,000
- b. **Revision proposed in the 7th Executive Committee Meeting (2 February 2026):**
 - 1) Associate Members: Rs. 20,000
 - 2) Corporate Members: Rs. 30,000

3. Opening.

After quorum was established, the meeting commenced with recitation from the Holy Quran. The Chairman welcomed participants and explained the background:

- a. The last fee revision was in 2015.
- b. Due to inflation and rising operational expenses, the General Body in the 27th AGM (3 Dec 2025) revised the Annual Fee to Rs. 30,000 (Associate Member) and Rs. 60,000 (Corporate Member).
- c. Following requests from members, the matter was reconsidered in the EC Meeting (2 Feb 2026), which proposed reduced fees of Rs. 20,000 (for Associate members) and Rs. 30,000 (for corporate members).
- d. The General Body was requested to approve the proposed reduction.
