DISPUTES OR INTERPRETATION OF ARTICLES

53. Any disputes or differences of opinion in regard to interpretation or scope of application of these Articles of Association, which cannot be resolved by the Association itself, shall be referred to the Regulator of Trade Organizations appointed under the Trade Organizations Act. 2013 and the ruling given by the Regulator shall be binding on the Association its office-bearers and members.

GENERAL

- (a) It will be obligatory upon the members of the Managing Committee to attend every meeting of the Managing Committee. In the case a member fails to attend three consecutive meetings of the committee he shall cease to be a member of the Committee. The Committee will and shall have the power to sanction leave to any member or reasonable grounds.
 - (b) The Managing Committee shall be-option by simple majority in the Managing Committee fill a vacant seat that may fall vacant.



Annex III

The Electoral Role

- The association shall have one electoral role consisting of members from the north and south region.
- Eligible voting Members of the association shall have the right to vote for the contesting candidates participating from both the north or south regions.
- The eight seats of the Managing committee, that shall fall vacant every year shall be filled from the eligible voters with 4 nominations from the North region electoral and 4 nominations from the south region electoral.
- That if more than 8 nominations are received collectively from both the regions, elections shall be held
- The seat of the Chairman shall rotate every year between the North and South region.

Eligibility & acceptance of Nominations

- Any member of the association who is eligible to vote and whose name appears on the provisional voters list shall have the right to apply for the seat of the managing committee PAAPAM.
 - Provided further that he fulfills the following conditions: -
 - The intending candidate must have served as a member of any working committee of PAAPAM for at i. least two years.
 - ii. The nomination form is accompanied with a donation of Rs 25000/-
 - Provided further that nominations of the office bearers shall fulfil the following further conditions: -
 - The nomination of the Chairman, Senior Vice Chairman and Vice Chairman shall further be iii. accompanied with a donation of Rs 50000, Rs 25000/- & Rs 15000 each respectively. iv
 - The firm of the contesting candidate has been supplying components to two OEMs. . The firm must hold Purchase Orders from these OEMs for the last three years.
 - Any current Managing Committee member whose dues are not clear is not eligible to vote in the election of the

Further resolved that these Bye laws be presented before the next Annual General meeting for inclusion in the Articles of Memorandum as a new ARTICLE 22 (V) with necessary approvals of the competent authorities.
