Agenda Item # 1: Approval on Last Minutes of Meeting

The draft of the minutes of the last MC meeting circulated among the members. Since no member had any reservation. Hence the minutes stand approved.

Agenda Item # 2: Suggestions for Making TORs for the revision of SRO 693

Resolved that Two members (i) Mr. Usman Aslam Malik (ii) Mr. Ashraf Sheikh will be representing PAAPAM in TORs Committee formed by EDB.

All members endorsed the decision.

Following suggestions were given to make TORs for the revision of SRO 693.

- Merger of all Passenger cars upto 2000 cc into one category and homogenization & Identification of Nomenclature of parts with pictures for all passenger cars and SUVs up to 2000 cc. To make one list for every type of vehicle (i.e., car, tractor, HCV etc.) Stick to Technology rather than engine type.
- There should be a periodic review mechanism (i.e., Grievance addressal committee with representation of PAAPAM) for SRO 693 revision to remove the anomalies in updated lists annually or biannually.

- One year grace period shall be provided to OEM to inform EDB for localization of any part. Control Mechanism is that EDB shall follow-up on the OEMs on the basis of IORC granted to the vendor as per PO issued by OEM.
- To make this revision process system driven rather than manual. PAAPAM may contribute for making a web-based software.
- To make broader heads of TORs and details of each respectively
 - Process of up-dation
 - Control mechanism
 - Review mechanism
 - Grievance addressal mechanism
- To make a timeline of review committee to avoid delay of up-dation process.
- To suggest EDB make it a responsibility of OEMs to provide lists of parts localized in since 2006.
- To suggest a reward mechanism for higher localization by OEMs (i.e., 2% relief on CKD duty over 65% localization and 4% relief on CKD duty over 75% localization etc.).

All members agreed on the proposed suggestions.

Agenda Item # 3: Possibility of Holding PAPs in November 2021

Resolved that if COVID-19 situation is clear till November and Expo Centre is available then PAPs show will be held in November 2021 in Karachi. If it is not possible to conduct show in November 2021 due to the COVID situation and mass gathering restriction then next year 2022 PAAPAM Karachi and PAAPAM Lahore will have a Joint Expo on mutually decided venue (i.e., Lahore or Karachi).

All members agreed the proposal.

Agenda Item # 4: Any other point with the permission of the chair.

No other issue discussed.

Chairman PAAPAM adjourned the meeting with thanking remarks to all MC members for being on the same page and having trust in the management.
